**A. ORGANIZATION.** The AC Milan Junior Camp (named as Milan Junior Camp) of Cortina d'Ampezzo (Alps - Dolomites), Asiago Mountain Plateau - Gallio (Alps), Jesolo Lido (Venice) and Lignano Sabbiadoro (Venice Area) are organized by ASD Sporteventi, Via Pastore, 44, 31029, Vittorio Veneto (TV), Italy, C.F. and VAT number 03839320268, email: milancamp@sporteventi.it, web-site: www.sporteventi.com; office number +39 0438 941366, mobile + 39 3488746938.

**B. MILAN JUNIOR CAMP - JUNIOR formula.** The Milan Junior Camp - Formula JUNIOR is the AC Milan-residential-formula camp with hotel staying for the participants/registrants. The subscription cost of one week of Milan Junior Camp includes full-board accommodation (FB) and lodging in hotel, from Sunday at 2 pm (lunch not included) to Saturday at 1 pm (lunch included), sports kit marked AC Milan Academy – Puma – Fly Emirates, sport activities, daily washing of (only) the AC Milan Training T-shirts, shorts and socks (no underwear), transportation service by private coach to and from the football pitch (if necessary), third-party liability insurance. Prices are all inclusive except for telephone calls and extra-drinks (water is included). **In case of participation at two camps in a row, the AC Milan-kit will be assigned to the participant/registrant only once at the beginning of the first camp.** Enrolment fees are the following ones:

**C. MILAN JUNIOR CAMP - DAY formula.** The Milan Junior Camp - Formula DAY is the AC Milan camp without hotel staying for the participants/registrants. The subscription cost of one week of Milan Junior Camp includes lunch from Monday to next Saturday, sports kit marked AC Milan Academy – Puma – Fly Emirates, sport activities, daily washing of (only) the AC Milan Training T-shirts, shorts and socks (not underwear), transportation service by private coach to and from the football pitch (if necessary), third-party liability insurance. Prices are all inclusive except for telephone calls and extra-drinks (water is included). **In case of participation at two camps in a row, the AC Milan-kit will be assigned to the participant/registrant only once at the beginning of the first camp.** Enrolment fees are the following ones:

**Please note:** The Day-Formula Camp program is identical to that of the Junior-Formula Camp. The only difference concerns its duration: the Day-Formula Camp runs approximately from 8:30 a.m. (breakfast not included) to 6:30 p.m. (dinner, evening activities, and hotel accommodation not included).

**D. ARRIVAL TIME.** In no case will the camper be taken over by the ASD Sporteventi staff before the start of the camp (at 2.00 pm on Sunday); parents and / or carers will have to look after the children until the mentioned time (surveillance and food) even if they arrive at the camp site on Sunday morning.

**E. DISCOUNT.** A discount of 130,00 Euros in case of Junior-Formula camp and 100,00 in case of Day-Formula camp is granted for all brothers and sisters who attend the same Milan Junior Camp. This discount can be assigned only once regardless of the number of weeks of registration camp.

**F. FINALIZATION OF THE ENROLLMENT PROCESS.**

The enrolment process is not considered concluded if:

1) the participant/registrant's parent/guardian refuses to sign the attachments of the entry form (Corporate Code of Ethics and Conduct; Information and rules; privacy policy; release for the use of audio/video and photographic recordings; healthcare proxy; declaration of responsibility).

In hypotheses 1) the amount paid will not be returned.

By signing the Corporate Code of Ethics and Conduct and information and rules, parents/guardians undertake to respect the requirements that apply to them.

**G. HEALTH CERTIFICATE.** Please provide together with this application-form a medical certificate (Family Doctor's Clean Bill of Health) where the doctor recognized by the National Health System, having examined the child/boy (participant/registrant), states:

- not having diagnosed any clinical signs restraining the practice - in competition or not - of football/soccer and specifically of the football/soccer sport activity named as "AC Milan Junior Camp" which is a not-competitive-summer-football camp for children/boys aged 6-16
- that the electrocardiogram (ECG) is not needed / The electrocardiogram (ECG) doesn't show any sign of detectable illness / disease;

- that the subject does not show any sign of detectable contagious illness / disease.

The medical certificate, not older than one year from the beginning of the camp, must cover the entire period of the camp, otherwise the registration will be cancelled.

Nobody will be admitted to the camp without the Health Certificate or with a wrong one.

**H. PAYMENT CONDITIONS.** At the time of subscription a down payment should be necessarily made of 400 Euro (three hundred fifty); the outstanding amount should be paid 30 days before the beginning of the selected period; **for registrations received after May 1, 2026 the payment must be done for the full amount of the fee at the registration (no deposit payment).** Payment has to be done (always specifying as "reason of the payment of the wire transfer" **the participant's name and surname**) with a wire transfer to **ASD SPORTEVENTI**, c/c no. (bank account number) 104571205890 at Banca Popolare dell'Alto Adige, Agency (filiale) of Vittorio Veneto (TV), IBAN: **IT02B0585662190104571205890** and SWIFT code: **BPAAIT2B104**. The ones that would like to pay by credit card (only VISA or MasterCard) shall contact the Secretary Office staff (margherita@sporteventi.it).

**I. CALL-OFF.** The entire registration fee will be returned upon cancellation by the subscriber, if communicated by email at least 30 days before the start date of the chosen Milan Junior Camp. In the event of an injury or illness, proven by a medical certificate, the registration can be cancelled up to the Thursday before the start date of the chosen Milan Junior Camp. Under no circumstances will anything be refunded once the camp has started.

**J. OVERNIGHT STAYING SATURDAY - SUNDAY.** Whoever wishes to make two camp-periods in a row, staying at the camp under the supervision of the Sporteventi staff, should pay an extra-cost at the time of registration for Saturday dinner, overnight stay, Sunday breakfast and lunch and the supervision during camp changeover of 130 Euros in Cortina d'Ampezzo and Asiago Plateau – Gallio, 115 Euros in Jesolo and 110 Euros in Lignano Sabbiadoro.

**K. INTERRUPTION OF AC MILAN JUNIOR CAMP.** It is understood that, in the event of interruption of the Milan Junior Camp for health reasons, at any time it occurs, the amount paid will not be returned even in part.

**L. RELIEF FROM RESPONSIBILITY AND DAMAGES.** I, the undersigned

\_\_\_\_\_, as the parent/guardian exercising parental authority over my son/daghter (participant/registrant) \_\_\_\_\_, under my personal responsibility I declare to expressly waive ASD Sporteventi and each one of its employees and / or appointed person from any liability for any damage arising from events that are caused exclusively by my son – participant/registrant (including, by way of example yet not comprehensive, not authorized independent initiatives taken by my son during his stay at the Milan Junior Camp), or by circumstances beyond the supply of the services offered (such as, but not limited to, the transfer to and from the chosen location, if not included in the attendance fee), by accident, force majeure, or by circumstances that the ASD Sporteventi itself could not, with the due professional diligence, reasonably foresee or resolve. I furthermore declare to relieve ASD SPORTEVENTI and any member of its staff or appointed person from any responsibility for damages that the participant/registrant should cause during the Milan Junior Camp. In any case should damages occur to premises and hotel equipment they will be charged to the participant/registrant who will be found responsible for them, or, if not possible, shared equally among the roommates.

**M. CHARGE AUTHORIZATION.** In the event that the participant/registrant requires urgent medical care, as determined by ASD Sporteventi's staff (as Manager of the Milan Junior Camp), parent/guardian's credit card will be charged for the cost of such care/treatment (alternatively, extra-costs can be paid by bank transfer); in the event that the participant/registrant damages premises and hotel equipment, as determined by ASD Sporteventi's staff (as Manager of the Milan Junior Camp), parent/guardian's credit card will be charged for the cost of such damage (alternatively, extra-costs can be paid by bank transfer). All fees to be in Euros.

**N. EXPRESS CANCELLATION CLAUSE.** In the event that during the time at the Milan Junior Camp (including, by way of example yet not comprehensive, sport activities, extra-activities, transportation, stay in the hotel) the participant/registrant's behaviour breaks in any way the normal rules of civil cohabitation or is against the rules given by the coaches or other members of the staff, then said participant/registrant may be removed from the Milan Junior Camp and this contract will be considered legally cancelled therefore ASD SPORTEVENTI will be allowed to retain all amounts received by it and to legally demand compensation.

**N.B.: It is also underlined that the members of the staff of the Milan Junior Camp do not have the professional skills to manage situations of mental distress or mental disorder in a broad sense.**

**O. SPORTEVENTI MEMBERSHIP.** This also represent the application form for the ASD Sporteventi membership. In case of acceptance of your application the membership fee of 10,00 euro is included in the fee of the point A. and B. herewith.

**P. DISPUTES' COURT:** Should any dispute arise the competent Court will be that of Treviso any other courts excluded.

## INSURANCE INCLUDED

ASD Sporteventi provides for two kinds of insurances for the protection of the camp participant/registrant:

1. **Third-party liability Insurance with a maximum cover of 5.000.000,00 euros.**
2. **The Individual Accident Insurance; we underline that this insurance is effective ONLY for the Italian participants who are also covered by the Italian National Health System. Therefore the participants NOT ITALIANS MUST provide for an accident insurance covering risks of injuries, illnesses and hospitalization during their staying in Italy for at least 200.000 Euros**

## ADDITIONAL SERVICES INCLUDED

- **Supervisors.** Supervisors are former AC Milan players of proven national and international fame and prestige or coaches or managers of crucial importance. They stay at the camp all throughout the week.
- **Assistance 24 hours a day.** Coaches and staff members of the AC Milan Junior Camp, qualified and specialized personnel, selected by Sporteventi, live in the hotel with the participants/registrants and supervise the rooms also at night.
- **Assistants.** At the AC Milan Junior Camp one or two female assistants are present in particular to take care of the participants/registrants injured and of the youngest participants who might be homesick during the first days of camp.
- **Transfer service.** We guarantee transfer services with a private bus from the hotel to the soccer pitches and back.
- **Bottled Mineral water distribution.** Bottled Mineral water is always available in the playing field.
- **Healthy food.** Food is very important and that is why the delicious "Bibanesi" are always present as main courses, a guarantee of quality. Twice a day, at mid-morning and midafternoon, participants/registrants of the Milan Junior Camp will have snacks.
- **Ongoing washing of the AC Milan Kit.** The sports garment of the AC Milan Kit are numbered to be easily recognizable by their respective owners and are therefore always washed to ensure top hygiene conditions.

## SMARTPHONES, PADS AND ACCESS TO PARTECIPANTS' ROOMS

The participant/registrant can bring mobile phones, smartphones and PDAs to the camp exclusively for the purpose of keeping in touch with his family.

Telephone calls to the participant from parents are generally accepted (except in real emergencies) **from 1.15pm to 2.00pm and from 8.30pm to 9.30pm**, i.e. after lunch and dinner.

In order to moderate and limit the use of telephones and PDAs **during the night (from 10.30pm to 7.30am)**, at 10.30pm - during the first room check - overnight participants (JUNIOR-formula) will be asked to **deposit their cell phones, smartphones and PDAs in the safe of their room**. The **combination** of the safe will be set and known only by the ASD Sporteventi staff and the hotel management. The safe will be reopened **between 7.30am and 8.00am** in the morning by the staff. This protocol aims to prevent children from spending hours on the phone at night, especially on social networks, or from being disturbed by those who do.

We underline that the staff generally cannot access the participants/registrants' rooms for reasons of minors' privacy (legal provisions) except for justified and urgent reasons (including, by way of example yet not comprehensive, state of necessity of the participants, disturbing noises, illness).

It is therefore not possible to monitor the behaviour of the participants regarding the use of smartphones and PDAs nor to proceed with their seizure (unless this is requested directly by the parents/guardians). The only way to regulate smartphone/PDAs use in participants/registrants' accommodation is for parents/guardians to set PARENTAL CONTROLS.

**So we remind you that it is ALWAYS MANDATORY to activate the PARENTAL CONTROL!**

In case of proven reasons of necessity (homesickness is not among them), specifically communicated to the secretariat office ([margherita@sporteventi.it](mailto:margherita@sporteventi.it)), exceptions will be allowed.

## INFORMATION CONCERNING THE PROCESSING OF PERSONAL DATA PURSUANT TO ARTICLES 13 AND 14 OF THE REGULATION EU 2016/679

Dear Madame / Sir,

In your capacity as a "Data Subject", that is, as the individual to whom the data processing refers, or as the "Responsible" party, we wish to inform you of a series of information relating to the ways personal data is used.

### Purpose of the processing:

The collection and processing of personal data are carried out in order to conduct:

1. the fulfilment of all operations imposed by regulatory obligations;
2. the establishment and execution of current contractual relationships, including the acquisition of information prior to the conclusion of the Contract;
3. the management of relations with the Client for administration, accounting, invoicing, and management of any litigation;

Personal data will be processed according to the principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

### Processing methods:

The processing of data for the purposes set out above takes place in an automated fashion, with the support of electronic media, and on paper by means of operations involving the collection, registration, organization, storage, consultation, processing, use and deletion of data.

### Processing location:

### Mandatory or optional nature of the provision of data:

Some data are essential for establishing a contractual relationship or for its execution, while others can be defined as ancillary to these purposes. The provision of data to the undersigned is mandatory only for data for which there is a legal or contractual obligation.

### Consequences of a refusal to provide data:

In cases where the provision of data is foreseen by a legal or contractual obligation, any refusal would put the Data giver in the condition of not being able to execute or continue the Contract as it would then lead to illicit processing. In cases where there is no legal obligation to provide data, the refusal would not have the consequences mentioned above, but could prevent the execution of ancillary operations.

### Communication of data:

Without prejudice to communications and dissemination carried out in compliance with legal obligations, the data may be communicated in Italy and/or abroad to:

- Professionals and consultants, law firms, insurance companies etc.

- Public and private entities, including inspections or audits carried out by: Financial Administrators, Tax Police Bodies, Judicial Authorities, the Italian Exchange Office, Labour Inspectors, Health or Security Institutions, the Chamber of Commerce, etc.;
- Public or private entities entitled to request the data;
- Subjects designated as external processors, including companies or professionals providing IT support, accountants, or companies belonging to the same group;
- Special data will be disseminated only as need or for health assistance.

### Data Retention time:

The data provided will be stored in our archives for the duration of the contract and, after termination, for 10 years as established by Art. 2220 C.C.. In the case of litigation, the duration is the same.

### Data transfer:

The data will be disseminated abroad exclusively for the purposes described above.

### Rights of the data subject:

We inform you that, as a data subject, you have the right to:

- obtain confirmation of the existence or not of your personal data, even if not yet registered, and know such data may be made available to you in an intelligible form and that you may obtain access to the data that relates to you;
- obtain the updating, rectification of incorrect data, integration or deletion thereof, as well as restrict processing.
- exercise the right to withdraw consent at any time if expressed;
- Regardless of the automatic processing that occurs, receive personal data that concerns you without hindrance and in a structured, commonly used and legible format in order to transmit them to another data controller or — if technically feasible — to obtain direct transmission from the Owner to another holder;
- oppose processing in cases of legitimate interest by the owner;
- lodge a complaint with the Authority for the Protection of Personal Data.

## INFORMATION AND RULES

### Participants

The participants are children/young people aged 6 –16.

Once a participant has joined the camp, he will stay overnight and eat at the hotel within his group.

Day-Formula participants (not residential) will be admitted to the camp.

Each participant's details will be registered, and the register will be kept for at least 14 days from the last day of the camp.

### Participants' parents/guardians

Parents/guardians will be able to interact with participants after the start of the camp:

- Without accessing the hotel rooms where the participants are staying overnight
- Without accessing the means of transport that the participants use to access activities

### Kit

On the Sunday at the start of the camp, all the participants will be assigned with clothing and provided with an identification number. Upon delivery, the staff will make a visual assessment of the size of the garments previously assigned to the participants, without the latter touching them.

Once the kits have been assigned, the garments will remain with the participant and cannot be changed.

### Clothes washing

The kits will be placed in washing bags by the participants and collected by the staff, who will allow the participants to place them in a trolley. This transfer will take place at the doorways of the rooms, with the trolley passing through the corridor.

The marked bags will then be entrusted to an internal or external laundry service.

### Participant arrival

All minors must arrive accompanied by their parent or guardian or by a person delegated by the family.

Participants should arrive around 2 pm. The participants will be assigned a number. Participants will undergo a temperature check. Parents cannot access the hotel rooms (never) and the lobby (during the check-in).

Participants will be assigned an overnight room where, with the help of the staff, they can leave their luggage and be assigned their kit. The overnight rooms and the group occupying them will remain the same throughout the camp.

### Transport

Bus transport is provided to transfer participants between the hotel and the playing field.

The means of transport is equipped with a certified sanitisation system that prevents air recirculation.

### Football activities on the pitch (outdoors)

During football activities on the pitch, the provisions related to contact sports apply.

The public cannot be present during the activities inside the pitch.

Participants will leave the hotel in their kit, ready for activities.

Each participant must have their own clearly marked water bottle for their exclusive use.

### Sports activities in the gym

In the event of bad weather, sports activities will be held in the gym.

The public cannot be present during the activities inside the area of sporting activities.

Participants will leave the hotel in their kit, ready for activities.

Each participant must have their own clearly marked water bottle for their exclusive use.

### Extra-activities

The extra-activities (not – sport activities) consist of walks in the surrounding area (sea or mountains), outings in the city centre or in neighbouring open spaces.

### Breakfast, lunch and dinner

Meals (breakfast, lunch, dinner) for participants and staff will be served within the hotel.

The staff will have their meals seated at their own table.

### Check-out

The participants and their luggage will be handed over to their families by the staff on Saturday, from 1pm to 2 pm outside the hotel lobby.

If the participant leaves the camp before this time, a specific notification must be made to the AC Milan Junior Camp secretariat. An exception concerns the AC Milan Junior Camp in Lignano Sabbiadoro from 3 to 10 August: in this case the participant (Junior – Formula) is returned by the staff to the family with his/her luggage on Sunday morning at 9:00 am outside the hotel lobby or the agreed area in the host sports village; the non-staying participant (DAY – Formula), on the other hand, ends the camp after the awards ceremony, that is, Saturday evening at 10.30 pm, in which he/she participates accompanied by an adult.

From that moment on, the minor is no longer a participant of the AC Milan Junior Camp.

### Mobile phones – smartphones - PDAs

Following the protocol that will adopt for the use of mobile phones, smartphones and PDAs during the Milan Junior Camp.

The participant/registrant can bring mobile phones, smartphones and PDAs to the camp exclusively for the purpose of keeping in touch with his family.

Telephone calls to the participant from parents are generally accepted (except in real emergencies) from **1.15pm to 2.00pm** and **from 8.30pm to 9.30pm**, i.e. after lunch and dinner.

In order to **moderate** and limit the use of telephones and PDAs **during the night (from 10.30pm to 7.30am)**, at 10.30pm - during the first room check - overnight participants (JUNIOR-formula) will be asked to **deposit** their mobile phones, smartphones and PDAs **in the safe off their room**. The **combination** of the safe will be set and known only by the Sporteventi staff and the hotel management. The safe will be reopened **between 7.30am and 8.00am** in the morning by the staff. The devices (smartphones, cell phones and PDAs) can be recharged by the participant during meals (their use in the restaurant is not permitted).

The Sporteventi staff stay on the same floors as the participants. A second check of the rooms (checking that the kids are sleeping and that everything is quiet) is done by the staff at midnight. Parents will have two telephone numbers (manager and assistant) who can be reached at any time of day or night in case of need. The staff itself is available to participants even in the middle of the night in case of need, as well as that of the hotel. The Sporteventi staff will immediately take action in the event of concrete problems that may arise (indispositions, homesickness, etc.) to notify the families to which they belong.

**This protocol aims to prevent children from spending hours on the phone at night, especially on social networks, or from being disturbed by those who do.**

We underline that the staff generally cannot access the participants/registrants' rooms for reasons of minors' privacy (legal provisions) except for justified and urgent reasons (including, by way of example yet not comprehensive, state of necessity of the participants, disturbing noises, illness).

It is therefore not possible to monitor the behaviour of the participants regarding the use of smartphones and PDAs nor to proceed with their seizure (unless this is requested directly by the parents/guardians). The only way to regulate smartphone/PDAs use in participants/registrants' accommodation is for parents/guardians to set PARENTAL CONTROLS.

**So we strongly remind you that it is ALWAYS MANDATORY to activate the PARENTAL CONTROL!**

In case of proven reasons of necessity (homesickness is not among them), specifically communicated to the secretariat office (margherita@sporteventi.it), exceptions will be allowed.

## CORPORATE CODE OF ETHICS AND CONDUCT

### The meaning and importance

Through the Corporate Code of Ethics and Conduct, the ASD Sporteventi (Association) wishes to convey substantive and behavioural norms that are to be observed and adhered to by all those who work within the Association.

This Corporate Code of Ethics and Conduct represents the Association's desire to promote, in the exercise of all its functions, a high standard of quality and professionalism in the executions of sports activities and all activities attributable to the Association itself, thus prohibiting conduct that conflicts with the Ethical and Moral values that the Association intends to promote and guarantee.

The Corporate Code of Ethics and Conduct sets forth the fundamental duties of loyalty, honesty, fairness and diligence expected of all those involved in association life.

### Recipients of the Corporate Code of Ethics

The recipients of the Corporate Code of Ethics and Conduct, who are obliged to observe the principles contained therein, are: members, managers, parents of members, coaching staff, collaborators (including occasional ones), suppliers, and anyone who carries out activities in the name and on behalf of the Association or under its control.

The Corporate Code of Ethics and Conduct will be delivered to all stakeholders and available on the Association's website.

### Efficacy

The Association is responsible for delivering the Corporate Code of Ethics and Conduct to all those involved, and signing it obliges those concerned to share its principles, aims and purposes, to observe all the provisions contained therein, to contribute to their application, and to assume the responsibilities resulting from their violation, which constitutes serious non-compliance and is deserving of the disciplinary sanctions provided for by the Association.

The Association is committed to operating in full compliance with the current legal and sports system, upholding the principles of loyalty, honesty, fairness and transparency in every aspect referable to its activities.

The Association is committed to the fight against sports malfeasance and therefore obliges people working in its name to work to ensure that such phenomena do not occur.

The Association, within its sphere of influence, is committed to supporting initiatives aimed at promoting actions to prevent the risk of unethical behaviour and to actively cooperate in the orderly and civilized coexistence of sports.

The Association undertakes not to have any relationship with any person who does not operate in accordance with the rules and principles expressed in this Corporate Code of Ethics and Conduct.

### Duties of the Amateur Sports Association

In particular, the Association is committed to:

- to promote actions to spread a healthy sports culture in sharing the inherent educational, training and social purposes;
- to support initiatives aimed at spreading sports for all by enhancing its ethical, human and fair-play principles;
- to refrain from any conduct likely to cause harm to people's health, ensuring that health, safety and mental and physical well-being assume a primary role;
- to avoid behaviour that in any way results or may result in incitement to violence;
- ensure that all individuals with responsibility for children and youth are well qualified to lead, train, educate, and coach according to the different levels of sports engagement;
- ensure the necessary supervision of children and young people by ensuring that relations with them are conducted in an irreproachable manner from the standpoint of moral propriety.

### Rules of conduct

All those who work within the Association must be aware of the current regulations governing and regulating their functions and must commit themselves to carrying out their activities with commitment, moral rigor, transparency and fairness also in order to protect the very image of the Association.

Everyone, within the scope of their specific activities, must conform their conduct to full compliance with the principles of loyalty, honesty, impartiality and moral integrity, avoiding conduct likely to adversely affect internal relations, thus ensuring mutual respect and respect for the rights and freedoms of individuals.

No one should abuse his or her role in the organization; instead, one should respect one's employees and foster their professional growth as well as the development of their potential.

No one may procure personal gain in connection with the activity being conducted.

It is forbidden to make statements or make judgments that may in any way harm the image of the Association or be detrimental to the reputation of other persons, entities or Associations.

### Participants

The primary objective of the Milan Junior Camps branded Sporteventi is to provide an engaging and unforgettable experience for all the children who will take part in the activities and to make them acquire, not only specific technical and competitive skills, but also ethical and social values that contribute to the formation of responsible youngsters. For this to be possible, it will be essential to create a pleasant atmosphere, in a safe and protective environment, respecting simple and unbreakable rules of good behaviour and coexistence.

Participating children are asked to abide by certain rules aimed at preventing inappropriate behaviour and useful in maturing an awareness of respect for common rules for civil coexistence, thus ensuring the proper conduct of relations within the Milan Junior Camp, in a context of cooperation and mutual respect for the benefit of the individual and the community.

Transgressions of behaviour rules will be carefully evaluated, will be reported to families, and may result in infra measures.

### Rules of conduct:

- participants must maintain a respectful and polite attitude toward other participants, the coaches, the Staff, and the staff operating in their host facilities, keeping well in mind the difference in roles between participants and adults operating on the staff;
- participants must always control your language, keep a normal tone of voice, and express yourself in a respectful and correct manner. The use of disrespectful, vulgar and demeaning words directed toward other participants and/or members of the staff is strictly prohibited;
- each participant must assume proper behaviour, acts of prevarication and violence toward others, acts of bullying, in any form manifested (physical or verbal violence), will neither be accepted nor tolerated by the Association;
- participants are required to behave respectfully toward the places, the environment and the materials provided. Children are expected to properly use the facilities and equipment provided, behaving in a way that does not cause damage;
- a reference number of the Camp secretary's office will be given to families for urgent communications upon arrival at Camp. It is forbidden to keep and use smartphones and PDAs during sports activities. Where the participant has a personal smartphone, it must be placed, along with other personal items, inside his or her backpack and may be used only at certain times of the day, determined by the staff. ASD Sporteventi disclaims any custodial responsibility in this regard;



- while staying at Milan Junior Camp, the possession and use of alcohol and/or drugs and/or other substances prohibited by law and/or forbidden to minors under the age of 18 is strictly prohibited;
- Appropriating and/or taking away materials and/or objects owned by others is strictly prohibited;
- Individual and/or group acts and behaviours that harm the dignity of the children participating in the Milan Junior Camp and respect for the human person (e.g. photos and/or filming) or for which there is danger to the safety of the person are prohibited. It is strictly forbidden to collect and disseminate texts, images, films, voice recordings without respecting the fundamental rights and freedoms of the people being filmed/recorded;
- It is compulsory for all participants to observe the organizational and safety regulations dictated by the regulations of the areas in which they come;
- each participant must be aware that the AC Milan jersey represents a set of fundamental principles and values (such as: FairPlay, education, respect for oneself and for others...), which must be respected at all times of the day and at all places frequented during the different activities.

In the **case of not-compliant behaviour**, the following actions will be taken:

- **in case the behaviour is sporadic and not particularly serious**, the staff will make a verbal warning to the participant for educational purposes, aimed at making the participant reflect and mature awareness and responsibility;
- In the case of **serious facts** that disrupt the smooth running of Milan Junior Camp activities or that may be a danger to people's safety, or even in the case of illegal or malicious acts that may constitute a crime (improper use of smartphones, PDAs, smoking, violent behaviour dangerous to oneself and others, behaviour disrespectful of human dignity, theft, damage to materials or places, etc. ), there will be the expulsion of the participant from the Milan Junior Camp, with no right to a refund of what has already been paid, and those exercising parental responsibility must immediately go to the Milan Junior Camp location to retrieve their children. In case of theft or damage, the exercisers of parental responsibility will be responsible for compensation for damages.

In no case will the free expression of opinions properly manifested and not detrimental to the personality of others be sanctioned.

#### Coaching staff

Coaches must transmit values such as respect, sportsmanship, civility and integrity that are the very foundation of sports.

For this reason, coaches must consider it their responsibility to transmit these moral values by committing themselves to the following principles:

- promote sports and its rules by exalting its ethical, human values and fair play;

- behave in an exemplary manner, behaving in accordance with the principles of loyalty and fairness, which is a positive role model for all; not rewarding disloyal behaviour or personally adopting it;
- refrain from any conduct likely to harm the physical and/or moral integrity of the people present;
- ensure, including through constant updating, that its preparation is adapted to the needs of young people and in particular children according to the different levels of sports commitment;
- dedicate equal attention and interest to all children regardless of individual potential.

#### Parents

Parents, in sharing the objectives that ASD Sporteventi sets itself through the adoption of this Corporate Code of Ethics and Conduct, in consideration of their role as educators and first teachers of the rules of behavior, with a view to the growth of their children in a healthy environment under the sign of an authentic culture of sport and its ethical values, in particular undertake to:

- to give young athletes, and especially children, a sports experience that educates them in healthy physical-motor activity by putting health and mental and physical well-being ahead of all other considerations;
- to foster in educational processes the culture of fair play and solidarity in sports;
- avoid raising and/or nurturing expectations disproportionate to their possibilities;
- promote a sports experience that knows how to enhance their children's potential while respecting their primary needs and special needs, proper to the natural processes of growth, avoiding all forms of pressure, including psychological pressure, and promoting a balanced and harmonious development of psycho-motor skills;
- value the pleasure and satisfaction of playing sports and not to exert undue pressure or pressure contrary to the young person's and/or child's right to freely choose about their participation;
- assume, during the course of competitions, attitudes and behaviours consistent with the principles of this Code of Ethics.
